RESOLUTION NO. 2002-28
CACHE COUNTY COUNCIL

A RESOLUTION ESTABLISHING THE TIME, LOCATION AND LANGUAGE OF A PUBLIC OPINION QUESTION TO BE PRESENTED TO THE PUBLIC REGARDING AN OPTION SALES AND USE TAX FOR THE PURPOSE OF FUNDING RECREATIONAL, ZOOLOGICAL, ARTS AND PARKS.

WHEREAS, a resolution authorizing a public opinion question to be presented to the public regarding an optional sales and use tax for the purpose of funding recreational, arts, parks, and zoo, that was passed by the Cache County Council on June 25, 2002.


THEREFORE, BE IT RESOLVED, that the public opinion question shall be presented during the same hours, and at the same locations as for the November 5, 2002 general election. Specific details are available from the Cache County Clerk.

FURTHER BE IT RESOLVED, that the language presented to the public on the ballot shall read as follows: "Should the Cache County Council, Utah, impose a 1/10th% of 1% sales and use tax for the purpose of funding recreation, arts, parks and zoos in Cache County, Utah?"


This resolution shall become effective immediately upon adoption.
