#4 Discussion: 2024 Code Amendment Priorities

Nelson reviewed the list of suggested 2024 code amendment priorities.

Staff and **Commissioners** discussed private roadway standards, flag lots, grandfathering old lots, resort development standards, short term rentals, detached accessory dwelling units (ADUs), living on property while home is under construction, Campgrounds/RVs on property, identifying potential gravel pit areas, and noise ordinances.

Phillips informed the Commissioners that there is policy regarding private roads not becoming county roads.

Staff and **Commissioners** discussed the road manual and bringing that before the Commissioners, zoning around Clarkston, how to regulate reservoirs and hydroelectric projects, civil code updates, and protecting animal habitat.
